The Admission Committee for Under-Graduate Studies of Bankura University in its meeting dated 29<sup>th</sup> August 2024 along with Principals/OICs/TICs of the affiliated colleges under Bankura University have approved the guidelines for implementation/execution related to the admission in Under-Graduate programmes for the academic year of 2024-25 in standalone mode to fill up the vacant seats (if any) in pursuance of the notification issued by the Government of West Bengal (vide No.554- Edn(CS)/10M-95/14, dated 21<sup>st</sup> August 2024), are as follows:

#### **Curriculum and Credit Framework for Undergraduate Programme (CCFUP):**

New Curriculum and Credit Framework for Undergraduate Programme, UGC 2022 (as per NEP 2020) for 4-years undergraduate programme(s) with “UG Degree Programmes with Single Major” only will be maintained for the academic session 2024-2025.

#### **Procedure of Admission:**

1. Necessary advertisement for on-line admission to the Undergraduate (UG) Programme for the academic year 2024-2025 will be made by the respective undergraduate colleges of their own (Standalone mode) as per the notification issued by the Government of West Bengal (vide N.O.554- Edn(CS)/10M-95/14, dated 21<sup>st</sup> August 2024). Online admission be completed by 30/09/2024 positively. The colleges will provide all the information related to the admission for Undergraduate Programme along with a helpline desk (time specific) through mobile/ email in their website in this regard.
2. The entire admission process should be made online, strictly based on merit. Prospective students should not be called for counseling or verification of documents during the process of admission. No physical presence will be required at the College / University.
3. Documents to be uploaded (not limited to) by the students while filling up the online application:
  - Admit card and Mark-sheet of Madhyamik Examination.
  - Mark-sheet of Higher Secondary Examination.
  - Caste Certificate (where necessary).
  - PH Certificate (where necessary).
  - EWS Certificate (where necessary).
4. Verification of the documents should be done only when the students report for the classes in due course by the respective college. Admission will be cancelled if the documents are found not in conformity with the declaration in the forms submitted online or any stage /time of the admission process.
5. All orders, notifications/Extant Rules//modalities issued by the Government of West Bengal including the notification (vide N.O.554- Edn(CS)/10M-95/14, dated 21<sup>st</sup> August 2024) are applicable and to be complied in the matters of admission and reservation rules.

**Sub: Online UG Admission in General Degree Courses for the Colleges under Centralized Admission Portal for the academic year 2024-2025 in standalone mode.**

The Undergraduate Admission in General Degree courses for Academic year 2024-2025 through the Centralized Admission Portal will end on 07.09.2024 after the completion of two phases.

To fill up the vacant seats (if any) in the Higher Education Institutions, the competent authority of the State Government decided that the admission process after 07.09.2024 will be conducted by the individual institution in online , stand alone mode.

**It is advised that the entire process of admission at UG level should be completed positively by 30<sup>th</sup> September 2024.**

All concerned is hereby informed that the admission to all Under Graduate programmes in the State –funded Higher Education Institutions in West Bengal for the ensuing session 2024-25 shall be made online in Standalone mode as per the modalities detailed below:

**Modalities:**

- 1) On-line admission process should be done strictly based on merit. Prospective students should not be called for counseling or verification of documents during the process of admission. No physical presence will be required at the HEIs.
- 2) No charges shall be taken from the students for (i) scanning/ uploading of documents for online admission and (ii) providing/making available the admission form in all UG level programmes.
- 3) Payment of fees should be done only through e-payment or designated banks and not physically at the colleges.
- 4) List of eligible applicants should be handed over to the designated bank branches for verification during payment through banks. Banks will receive admission fees based on merit list.
- 5) All testimonials are required to be uploaded online during application. Verification of documents should be done only when the students report for the classes in due course. Admission will be cancelled if the documents are found not in conformity with the declaration in the forms submitted on-line.

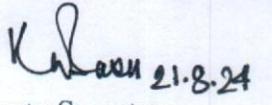
